REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF EAST RIDGE

August 10, 2023 6:00 pm

The East Ridge City Council met pursuant to notice on August 10, 2023, 6:00 pm at East Ridge City Hall. Mayor Williams called the meeting to order.

Pastor Robert Jones gave the invocation. All joined in the Pledge of Allegiance to the Flag.

Present: Mayor Williams, Vice Mayor Haynes, Councilmember Cagle, Councilmember Tyler, Councilmember Witt, City Manager Miller, City Attorney Litchford, and City Recorder Middleton.

Employee Milestone Awards for July – Mayor Williams announced the following milestone awards for July:

- Pamela Aalberg 10 years
- Sgt. Timothy Spires The Mayor presented Sgt. Spires with a plaque in honor of his 40 years with the City.

Approval of Minutes July 27, 2023 Council Meeting – Councilmember Tyler made a motion, seconded by Councilmember Witt, to approve the minutes. The vote was unanimous. Motion approved.

Communication from Citizens:

Mayor Williams stated there are several ordinances regarding rezonings, at which time, citizens will have an opportunity to speak during a public hearing or they may speak now. No one came forward to speak.

Communication from Councilmembers:

Councilmember Cagle, Councilmember Tyler, and Vice Mayor Haynes had nothing at this time.

Councilmember Witt asked everyone to remember the family for Drew Andrew in their prayers. His father, Andy, is in Hospice care.

Mayor Williams announced the following events:

Communication from City Manager:

- Multi modal project Storm drains, sidewalks, and curbing are being installed. Conduit and wiring for pedestrian lighting are being installed between Marlboro Avenue and Belvoir Avenue.
- Chattanooga Dental Arts Building was issued a building permit to be located just west of Jack's Family Restaurant on Ringgold Road.
- Council approved proceeding with Requests for Qualifications ("RFQ") for a Camp Jordan Sports Feasibility study. We received five RFQ's. A selection committee will review and will recommend the top two or three to make presentations to the Council sometime in mid-September.

Old Business:

ORDINANCE NO. 1190 – AN ORDINANCE OF THE EAST RIDGE CITY COUNCIL TO AMEND TITLE 13, PROPERTY MAINTENANCE REGULATIONS, OF THE EAST RIDGE CITY CODE, BY AMENDING CHAPTER 1, SECTION 104 TITLED OVERGROWN AND DIRTY LOTS (2nd and final reading) – City Attorney Litchford read on caption. City Attorney Litchford stated approval of this ordinance will bring the City into compliance with State law and help resolve issues with owner-occupied overgrown properties. Vice Mayor Haynes made a motion, seconded by Councilmember Witt, to approve Ordinance No. 1190 on 2nd and final reading. The vote was unanimous. Motion approved.

New Business:

Presentation from Air Pollution Bureau - Ron Drumeller, Executive Director – Mr. Drumeller is present on behalf of the Air Pollution Bureau requesting Council adopt revisions to air pollution ordinance recommended by the Bureau. These revisions have already been adopted by Chattanooga and Hamilton County. Mr. Drumeller discussed the revisions and stated that all municipalities need to adopt them.

PUBLIC HEARING FOR ORDINANCE NO. 1191 – Amendments to the East Ridge Municipal. Code, Title 20, Chapter 2, Air Pollution Control Ordinance – City Attorney Litchford read on caption. Mayor Williams opened the public hearing. No one came forward in favor of or in opposition to the ordinance. The Mayor closed the public hearing.

ORDINANCE NO. 1191 – AN ORDINANCE OF THE EAST RIDGE CITY COUNCIL TO AMEND EAST RIDGE MUNICIPAL CODE, TITLE 20, CHAPTER 2, WHICH CHAPTER IS KNOWN AS "THE EAST RIDGE AIR POLLUTION CONTROL ORDINANCE," BY PROVIDING FOR INCORPORATION BY REFERENCE OF CERTAIN FEDERAL REGULATIONS AND FOR CERTAIN HOUSEKEEPING PROVISIONS (1st reading) – City Attorney Litchford read on caption. Councilmember Witt made a motion, seconded by Councilmember Tyler, to approve Ordinance No. 1191 on first reading. The vote was unanimous. Motion approved.

PUBLIC HEARING FOR ORDINANCE NO. 1192 – Request of Stone Creek Consulting, LLC (Allen Jones) to have the properties located at 636 and 650 Layfield Road, Tax Map #170J-B-004.04 and #170J-B-004.05, from R-1 Residential District to R-3 Residential Apartment District – City Attorney Litchford read on caption. Mayor Williams opened the public hearing. Chief Building Official Howell stated there will be five units with parking at the rear of the property with one entrance for all units. It is compatible for the area. Allen Jones, Stone Creek Consulting, LLC, 1112 Wilmoth Road, Dunlap, TN is working with Evan Green the builder. Mr. Jones stated it is surrounded by R-3, and no one came forward with objections at the Planning Commission. No one came forward in favor of or in opposition to the rezoning. The Mayor closed the public hearing.

ORDINANCE NO. 1192 – AN ORDINANCE OF THE EAST RIDGE CITY COUNCIL TO AMEND THE ZONING REGULATIONS AND THE ZONING MAP OF THE CITY OF EAST RIDGE, TENNESSEE SO AS TO REZONE THE PROPERTIES LOCATED AT 636 AND 650 LAYFIELD ROAD, TAX MAP #170J-B-004.04 AND #170J-B-004.05, FROM R-1 RESIDENTIAL DISTRICT TO R-3 RESIDENTIAL APARTMENT DISTRICT (1st reading) — City Attorney Litchford read on caption. Councilmember Tyler made a motion, seconded by Vice Mayor Haynes, to approve Ordinance No. 1192 on first reading. Councilmember Cagle asked where the garbage containers would be located. Mr. Jones stated there will be a common corral for cans in a private alley. Roll call vote: Vice Mayor Haynes - yes; Councilmember Cagle - no; Councilmember Tyler - yes; Councilmember Witt - no; Mayor Williams - yes. Motion approved.

PUBLIC HEARING FOR ORDINANCE NO. 1193 – Request of Michael Meyers to have parts of the property located at 861 Donaldson Road (Parts of Tax Map ID #156L-C-012.01) and all the property located at 865 Donaldson Road (Tax Map ID #156L-C-013) from R-1 Residential District to RT-1 Residential Townhome District – City Attorney Litchford read on caption. Mayor Williams opened the public hearing. Chief Building Official Howell stated this would be four townhomes on 0.36 acres. The remaining 1.37 acres in the rear of the property will remain R-1. It is surrounded by residential and multi-family dwellings. Parking will be in rear due to concerns from the Planning Commission. Mike Price, MAP Engineers, 7380 Applegate Lane, Chattanooga, TN stated the garages would be at the rear of the townhomes and there will be a driveway with a single point of entry. No one else came forward in favor of or in opposition to the rezoning. Mayor Williams closed the public hearing.

ORDINANCE NO. 1193 - AN ORDINANCE OF THE EAST RIDGE CITY COUNCIL TO AMEND THE ZONING REGULATIONS AND THE ZONING MAP OF THE CITY OF EAST RIDGE, TENNESSEE SO AS TO REZONE PARTS OF THE PROPERTY LOCATED AT 861 DONALDSON ROAD, PARTS OF TAX MAP #156L-C-012.01, AND ALL OF THE PROPERTY LOCATED AT 865 DONALDSON ROAD, TAX MAP ID#156L-C-013 FROM R-1 RESIDENTIAL DISTRICT TO RT-1 RESIDENTIAL TOWNHOME DISTRICT (1st reading) — City Attorney Litchford read on caption. Vice Mayor Haynes made a motion, seconded by Councilmember Tyler, to approve Ordinance No. 1193 on first reading. Councilmember Cagle asked where the garbage would be picked up. Mike Price, MAP Engineers, stated either in the rear or in a corral where the City could pick it up. Roll call vote: Vice Mayor Haynes - yes; Councilmember Cagle - no; Councilmember Tyler - yes; Councilmember Witt - no; Mayor Williams - no. Motion to approve was denied.

PUBLIC HEARING FOR ORDINANCE NO. 1194 - Request of N&R Properties to have the property located at 1438 N. Smith Street (Tax Map ID#169L-K-001.01) rezoned from C-1 Tourism Commercial District and R-1 Residential District to RT-1 Residential Townhouse District — City Attorney Litchford read on caption. Mayor Williams opened the public hearing. Mike Price, Map Engineers, stated the plan was revised because the Planning Commission approved three units rather than four. The parking has also been shifted to the rear. A garbage corral will be placed on N. Smith behind McDonalds. No one else came forward in favor of or in opposition to the rezoning. Mayor Williams closed the public hearing.

ORDINANCE NO. 1194 – AN ORDINANCE OF THE EAST RIDGE CITY COUNCIL TO AMEND THE ZONING REGULATIONS AND THE ZONING MAP OF THE CITY OF EAST RIDGE, TENNESSEE SO AS TO REZONE THE PROPERTY LOCATED AT 1438 NORTH SMITH STREET, TAX MAP #169L-K-001.01 FROM R-1 RESIDENTIAL DISTRICT AND C-1 COMMERCIAL TOURISM DISTRICT TO RT-1 RESIDENTIAL TOWNHOME DISTRICT (1st reading) — City Attorney Litchford read on caption. Councilmember Witt made a motion, seconded by Councilmember Tyler, to approve Ordinance No. 1194 on first reading. Mayor Williams made a motion, seconded by Councilmember Witt, to amend the original motion to state that in Section 2, Item B should be added to state that no parking would be allowed on N. Smith Street. Roll call vote on the amendment: Vice Mayor Haynes – yes; Councilmember Cagle – abstain; Councilmember Tyler - yes; Councilmember Witt – yes; Mayor Williams – yes. Motion approved. Roll call vote on the original motion as amended: Vice Mayor Haynes – yes; Councilmember Cagle – no; Councilmember Tyler - yes; Councilmember Witt - yes; Mayor Williams – yes. Motion approved

PUBLIC HEARING FOR ORDINANCE NO. 1195 - Request of Verna Knight to have the property located at 205 Eads Street (Tax Map ID#158O-A-022.03) rezoned from R-1 Residential District to R-2 Residential Duplex District — City Attorney Litchford read on caption. Mayor Williams opened the public hearing. Chief Building Official Howell stated the owner wants to convert the home to a duplex and use the basement area for short-term vacation rentals. It is surrounded by single-family residential units. Mr. Howell also stated there are restrictive covenants of the Jordan Run subdivision that have been in place since 1986 and using the property as a duplex would violate those covenants. Mr. Litchford stated any approval of the Council is subject to the covenants. No one else came forward in favor of or in opposition to the rezoning. Councilmember Cagle stated he had been contacted by a resident on Beulah Drive, Curtis Baker, who objected to the rezoning because it would be a traffic hazard when people back out of the driveway. Verna Knight, 205 Eads St., stated her driveway is no different

than if two people lived there. Donna Morgan, 558 Austin Drive, stated her business, Itrip, would professionally manage the property. No one else came forward in favor of or in opposition to the rezoning. The Mayor closed the public hearing.

ORDINANCE NO. 1195 – AN ORDINANCE OF THE EAST RIDGE CITY COUNCIL TO AMEND THE ZONING REGULATIONS AND THE ZONING MAP OF THE CITY OF EAST RIDGE, TENNESSEE SO AS TO REZONE THE PROPERTY LOCATED AT 205 EADS STREET, TAX MAP #1580-A-022.03 FROM R-1 RESIDENTIAL DISTRICT TO R-2 RESIDENTIAL DUPLEX DISTRICT (1st reading) — City Attorney Litchford read on caption. Councilmember Cagle made a motion, seconded by Councilmember Witt, to deny Ordinance No. 1195. Mr. Cagle stated he made a motion to deny because of the lack of full firewalls. Mr. Tyler stated that the Council should respect the covenants in the subdivision. The vote was unanimous. Motion to deny was approved.

ORDINANCE NO. 1196 – AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF EAST RIDGE, TENNESSEE, TO AMEND THE FISCAL YEAR 2024 OPERATING BUDGET, ORDINANCE NO. 1186, BY CHANGING THE REVENUES AND EXPENDITURES OF VARIOUS FUNDS (1st reading) – City Attorney Litchford read on caption. Finance Director Qualls stated this amendment will cover the cost of the sanitation truck we ordered in February 2022 and just now received. Cost was \$266,000, which will come from the Sanitation Fund Balance. Councilmember Witt made a motion, seconded by Councilmember Tyler, to approve Ordinance No. 1196 on first reading. The vote was unanimous. Motion approved.

RESOLUTION NO. 3416 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EAST RIDGE, TENNESSEE, APPROVING AN APPOINTMENT TO THE EAST RIDGE HOUSING COMMISSION BY VICE MAYOR HAYNES – City Attorney Litchford read on caption. Vice Mayor Haynes made a motion, seconded by Councilmember Cagle, to appoint Grant Sowder to the Housing Commission. The vote was unanimous. Vice Mayor Haynes thanked Mr. Sowder for his willingness to serve and thanked Jim Winters for his service as a member and Chairperson of the Housing Commission.

RESOLUTION NO. 3417 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EAST RIDGE, TENNESSEE, APPROVING AN APPOINTMENT TO THE EAST RIDGE HOUSING COMMISSION BY COUNCILMEMBER WITT – City Attorney Litchford read on caption. Councilmember Witt made a motion, seconded by Councilmember Cagle, to appoint Jeff Ezell to the Housing Commission. The vote was unanimous. Motion approved.

RESOLUTION NO. 3422 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EAST RIDGE, TENNESSEE, APPROVING THE APPLICATION FOR AND ACCEPTANCE OF THE STATEWIDE SCHOOL RESOURCE OFFICER ("SRO") PROGRAM GRANT TO PLACE AN SRO IN EACH OF THE CITY'S PUBLIC SCHOOLS – City Attorney Litchford read on caption. Chief Uselton stated the grant would provide up to four SRO's at a maximum of \$75,000 per position. The City would have to provide the remainder of the cost for the SRO's. Councilmember Tyler made a motion, seconded by Vice Mayor Haynes, to approve Resolution No. 3422. The vote was unanimous. Motion approved.

EAST RIDGE CITY COUNCIL PRESENTATION

Good evening, Mr. Mayor and Commissioners. My name is Ron Drumeller and I am the Executive Director of the Chattanooga-Hamilton County Air Pollution Control Bureau. Today, I am here on behalf of the Air Pollution Control Board asking the City Council to adopt proposed revisions to the Hamilton County air pollution control regulations which ultimately will be adopted by legislative bodies throughout Hamilton County.

The Air Pollution Control Board has the responsibility of recommending changes in the air pollution control regulations to the various legislative bodies in the County. These proposed changes to the air pollution control regulations were the subject of a 30 day public comment period and a public hearing before the Air Pollution Control Bureau. No adverse comments were received on the proposed revisions. These revisions have already been adopted by Hamilton County and the City of Chattanooga.

The State of Tennessee requires that the air pollution control rules within all of Hamilton County be no less stringent than State rules. Many of these rules have their origin as federal rules promulgated by the U.S. Environmental Protection Agency. They are commonly adopted by reference by state and local jurisdictions to ensure national uniformity of rules and streamlining of state and local regulations since many of them are extremely lengthy. The State recently updated their rules for new sources and sources of hazardous air pollution and is requiring that our local rules be updated in order to be no less stringent than the State rules.

The proposed changes include:

- Adopting New Source Performance Standards (NSPS) for industrial sources of air pollution and National Emissions Standards for Hazardous Air Pollutants (NESHAPs) by reference as of July 1, 2021:
- Updating and adding some definitions;
- Adding three additional chemicals to be excluded from the definition for volatile organic compounds (VOCs);
- Updating the list of chemicals for which there are National Ambient Air Quality Standards (NAAQS);
- Adding electronic notice (e-notice) provisions;
- Updating stack testing requirements; asbestos regulations and fees; open burning rules;
 landfill rules; confidentiality provisions;
- Making minor administrative changes and corrections; and
- Correcting grammatical errors.

The Air Pollution Control Board unanimously recommends all of these revisions and has asked that the County and all its municipalities enact them in order to maintain local jurisdiction over air pollution control.

We want to thank you for sending us the revised ordinance package addressing both our and US EPA's comments for review. It appears our concerns have been addressed.

We appreciate the effort you are undertaking to keep your local ordinances current and in compliance with EPA's regulations and those of the state. As you are aware, this is a condition of the Certificate of Exemption (COE) for your local air program under the Tennessee Air Quality Act ("Act"). For the COE to be granted by the Board, the local program provisions must not be less stringent than those of the state, the local program must be adequately enforced, and the granting of the COE must not interfere with the state's goal of maintaining the purity of the air resources of the state. T.C.A. § 68-201-115.

To that end, keeping your local ordinances current with the state (and EPA) is a critical step towards meeting the requirements of your COE under the Act.

WHEREAS, it is the declared public policy of this city to achieve and maintain such levels of air quality as will protect human health and safety, and to the greatest degree practicable, prevent injury to plant and animal life and property, and to foster the comfort and convenience of the people; and

WHEREAS, local regulation of air quality is the most efficient means toward that end; and

WHEREAS, in order to maintain the Certificate of Exemption granted by the Tennessee Air Pollution Control Board for operating a local air pollution control program, it is necessary to adopt regulations no less stringent than state standards; and

WHEREAS, the adoption of these amendments is required for the protection of the health, safety, and welfare of the citizens of East Ridge and to insure maintaining the local Certificate of Exemption;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EAST RIDGE, TENNESSEE, that Chapter 2 of Title 20 of the East Ridge Municipal Code be amended as is hereafter set forth:

<u>SECTION 1</u>. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-202, is hereby amended so as to delete the definition of "Director" in its entirety and substitute in lieu thereof the following definition of "Director":

Director: The Executive Director of the Bureau.

SECTION 2. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-202, is hereby amended so as to delete the definition of "Hazardous air pollutant" in its entirety and substitute in lieu thereof the following definition of "Hazardous air pollutant":

Hazardous air pollutant: Any air pollutant listed in Title 42 U.S.C. 7412(b)(1), as revised by Title 40 CFR Part 63, Subpart C, which has been incorporated by reference in Chapter 2.

SECTION 3. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-202, is hereby amended so as to add the following definition of "PM_{2.5}":

*PM*_{2.5}: Particulate matter with an aerodynamic diameter of less than or equal to a nominal 2.5 micrometers as measured by a reference method based on Appendix L of Title 40 Code of Federal Regulations Part 50 and designated in accordance with Title 40 Code of Federal Regulations Part 53, by an equivalent method designated in accordance with Part 53, or by an approved regional method designated in accordance with Appendix C of Title 40 Code of Federal Regulations Part 58.

SECTION 4. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-202, is hereby amended so as to delete the definition of "Volatile organic compounds (VOCs)" in its entirety and substitute in lieu thereof the following definition of "Volatile organic compound (VOC)":

Volatile organic compound (VOC): Any compound of carbon, excluding carbon monoxide, carbon dioxide, carbonic acid, metallic carbides or carbonates, and ammonium carbonate, that participates in atmospheric photochemical reactions.

- (3) As a precondition to excluding these compounds as VOC or at any time thereafter, the Director may require an owner or operator to provide monitoring or testing methods and results demonstrating, to the satisfaction of the Director, the amount of negligibly-reactive compounds in the source's emissions.
- (4) For purposes of enforcement for a specific source, the test methods specified in these regulations, in the EPA-approved SIP, or in a permit or certificate issued pursuant to these regulations shall be used.

SECTION 5. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-203, is hereby amended so as to delete Section 20-203(b) in its entirety and substitute in lieu thereof the following:

(b) Procedures for ambient sampling and analysis. Sampling and analytical procedures required for particulate matter, particulate matter as PM₁₀, particulate matter as PM_{2.5}, ozone, sulfur dioxide, carbon monoxide, nitrogen dioxide, and lead may be found in Title 40 Code of Federal Regulations Part 50, Appendices A-1, A-2, B, C, D, F, G, H, I, J, K, L, N, O, P, Q, R, S, T, and U, which have been incorporated by reference in Chapter 2. The procedure for sampling and analyzing atmospheric fluorides shall conform with the method adopted by the American Society for Testing Materials (ASTM) and found in the Annual Book of ASTM Standards published in the most recent year prior to enactment of this ordinance year by the American Society for Testing Materials bearing ASTM designation D 3266 "Standard Test Method for Automated Separation and Collection of Particulate and Acidic Fluoride in the Atmosphere (Double Paper Tape Sampler Method)." Each ambient monitor sited in the field for the purpose of generating data for the monitoring procedures listed in Section 20-203(b) must have a valid data recovery of at least seventy-five percent (75%). Information that documents the cause of any missing data shall be submitted in writing to the Director.

SECTION 6. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-203, is hereby amended so as to delete Section 20-203(c)(2) in its entirety and substitute in lieu thereof the following:

(2) Stack gas flow rate determination. Stack gas flow rate shall be determined by Method 2, 2A, 2B, 2C, 2D, 2E, 2F, 2G, or 2H as set forth in Title 40 CFR Part 60, Appendix A, which has been incorporated by reference in Chapter 2.

(g) Public Notice Requirements. The Bureau shall notify the public, on a monthly basis, by publication as an electronic notice (e-notice) on the Bureau website for the duration of the public comment period and by other means designated by the Director, if necessary, of any applicants seeking to obtain a permit to construct or modify an air contaminant source. Provided, however, that modifications which do not result in a net emissions increase in the potential emissions of any air pollutant or that qualify as a minor permit modification will not be subject to the notice requirements of this paragraph. The notice shall specify the general vicinity or location of the proposed source or modification, the type of source or modification, and opportunity for public comment. Comments shall be in writing and delivered to the Director within thirty (30) days after the publication of the public notice. If there is no application during a particular month, no notice shall be required for that month. The Bureau may publish the notice for a single application if the source so requests. Any costs for all public notices required to be published, including those for federally-enforceable initial certificates of operation, Part 70 major source operating permits (initial and renewal), installation (construction) permits, PSD permits, and applicable modifications of any permit, shall be assessed to the applicant in addition to the associated permit fee. Where multiple sources are included in the published notice, any costs shall be apportioned equally between or among those multiple sources. The Bureau shall be required to publish notices pursuant to this section only in those months for which an actual application has been received and which is subject to these provisions. Failure to pay these costs shall constitute a violation of this ordinance for which enforcement action may be taken.

For sources subject to the Part 70 permit provisions at Article III of the Ordinance, the confidential information provisions of Section 20-256(a)(3) shall also apply in reviewing the request for treatment of information as confidential.

Nothing herein shall be construed to prevent the use of such information by the Bureau or Board in compiling or publishing analyses or summaries relating to the general conditions of the outdoor atmosphere provided that such analyses or summaries do not identify the owner, operator, or business or reveal any information considered confidential under this section.

The term "major source" as used in Section 20-220 means any of the following types of stationary sources of air pollutants which emit, or have the potential to emit, one hundred (100) tons per year or more of any air pollutant: fossil fuel fired steam electric plants of more than two hundred fifty million (250,000,000) British thermal units per hour heat input; coal cleaning plants (thermal dryers); draft pulp mills; Portland cement plants; primary zinc smelters; iron and steel mill plants; primary copper smelters; municipal incinerators capable of charging more than fifty (50) tons

of refuse per day; hydrofluoric, sulfuric, and nitric acid plants; petroleum refineries; lime plants; coke oven batteries; sulfur plants; phosphate rock processing plants; sulfur recovery plants; carbon black plants (furniture process); primary lead smelters; fuel conversion plants; sintering plants; secondary metal production facilities; chemical process plants; fossil-fuel boilers of more than two hundred fifty million (250,000,000) British thermal units per hour heat input; petroleum storage and transfer facilities with a capacity exceeding three hundred thousand (300,000) barrels; taconite ore processing facilities; glass fiber processing plants; and charcoal production facilities. The term "major source" also includes, for the purposes of Section 20-220, any other source with the potential to emit two hundred fifty (250) tons per year or more of any air pollutant. Only the pollutants for which the air quality planning area is designated nonattainment are considered in determining whether a source is a major source, for the purposes of Section 20-220.

<u>SECTION 22</u>. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-221, is hereby amended so as to delete Section 20-221(b) in its entirety and substitute in lieu thereof the following:

(b) No variance or renewal thereof shall be granted pursuant to this section except after public hearing on due notice by publication as an electronic notice (e-notice) on the Bureau website for a period of thirty (30) days prior to the public hearing and by other means designated by the Director, if necessary, and until the Board has considered the relative interests of the applicant, other owners of property likely to be affected by the discharges, and the general public.

SECTION 23. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-221, is hereby amended so as to delete Section 20-221(d) in its entirety and substitute in lieu thereof the following:

(d) Any variance granted pursuant to this section may be renewed on terms and conditions and for periods which would be appropriate on initial granting of a variance. If complaint is made to the Board on account of the variance, no renewal thereof shall be granted unless, following public hearing on the complaint notice, the Board finds that renewal is justified. No renewal shall be granted except on application therefor. Any such application shall be made at least thirty (30) days prior to the expiration of the variance. If composite sampling is used, equal volumes shall be taken from each sample probe. If more than the required number of samples are taken, all samples shall be used in the analysis. The landfill owner or operator shall divide the NMOC concentration from Method 25C of Appendix A of Title 40 CFR Part 60 by six (6) to convert from C_{NMOC} as carbon to C_{NMOC} as hexane.

SECTION 37. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-241, is hereby amended so as to delete the *first paragraph only* of Rule 15.3(d)(1)d and substitute in lieu thereof the following:

d. Tier 3. The site-specific methane generation rate constant shall be determined using the procedures provided in Method 2E of Appendix A of Title 40 CFR Part 60, which has been incorporated by reference in Chapter 2 and is described in Section 20-203(c). The landfill owner or operator shall divide the NMOC concentration from Method 25C by six (6) to convert from C_{NMOC} as carbon to C_{NMOC} as hexane.

4. (9) Category II nonfriable ACM means any material, excluding Category I nonfriable ACM, containing more than one percent (1%) asbestos as determined using the method specified in Title 40 CFR Part 763, Subpart E, Appendix E, Section 1 "Polarized Light Microscopy," which has been incorporated by reference in Chapter 2, that, when dry, cannot be crumbled, pulverized, or reduced to powder by hand pressure.

(17) Friable asbestos material means any material containing more than one percent (1%) asbestos as determined using the method specified in Title 40 CFR Part 763, Subpart E, Appendix E, Section 1 "Polarized Light Microscopy," which has been incorporated by reference in Chapter 2, that, when dry, can be crumbled, pulverized, or reduced to powder by hand pressure. If the asbestos content is less than ten percent (10%) as determined by a method other than point counting by polarized light microscopy (PLM), verify the asbestos content by point counting using PLM.

 - (ii) When the asbestos stripping or removal operation or demolition operation covered by Rule 17.5 will begin on a date earlier than the

date contained in the notice, the Director shall be notified of the new start date at least ten (10) working days before the asbestos stripping or removal operation or demolition operation begins.

Any certificate of operation issued to a synthetic minor source shall contain a statement of basis comparing the source's potential to emit with the synthetic limit to emit and a description of the procedures to be followed that will insure that the limit on which the Director bases a determination that a source is a synthetic minor source and not a "major source," as defined in this ordinance, is not exceeded;

SECTION 91. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-256, is hereby amended so as to delete the *first paragraph only* of Section 20-256(c)(11) and substitute in lieu thereof the following:

(11) The following activities, due to de minimis emissions levels, are deemed to be insignificant activities that need not be included in the permit application provided that potential emissions of each criteria pollutant from an activity listed in § 20-256(c)(11) by a Part 70 source are less than five (5) tons per year; and provided that potential emissions of any single hazardous air pollutant from an activity listed in § 20-256(c)(11) by a Part 70 source are less than one thousand (1,000) pounds per year; and provided that the activity involves no potential emissions of any Class I substance or Class II substance as defined in Title 42 U.S.C. 7671; and further provided that the activity listed in § 20-256(c)(11) is not subject to an applicable requirement, as that term is defined in § 20-253. Potential emissions of any air pollutant that is both a criteria pollutant and a hazardous air pollutant shall be subject to the more stringent threshold of one thousand (1,000) pounds per year for the purposes of § 20-256(c)(11).

SECTION 92. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-256, is hereby amended so as to delete Section 20-256(c)(11)(xvix [sic]) in its entirety and substitute in lieu thereof the following:

(xix) Laboratory equipment used exclusively for chemical and physical analyses, including ventilating and exhaust systems for laboratory hoods used for air contaminants other than radioactive air contaminants;

SECTION 93. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-256, is hereby amended so as to delete Section 20-256(c)(11)(il [sic]) in its entirety and substitute in lieu thereof the following:

(xlix) Equipment used for portable steam cleaning;

SECTION 94. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-256, is hereby amended so as to delete the *first paragraph only* of Section 20-256(c)(11)(lxxxvi) and substitute in lieu thereof the following:

(lxxxvi) Industrial-Commercial-Institutional Steam Generating Insignificant Activities are as follows:

SECTION 95. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-256, is hereby amended so as to delete the *first paragraph only* of Section 20-256(c)(12) and substitute in lieu thereof the following:

(12) The following activities, due to size and production rate, are deemed to be insignificant activities that must be included in the permit application in accordance with § 20-256 of this chapter provided that potential emissions of each criteria pollutant from an activity listed in § 20-256(c)(12) by a Part 70 source are less than five (5) tons per year; and provided that potential emissions of any single hazardous air pollutant from an activity listed in § 20-256(c)(12) by a Part 70 source are less than one thousand (1,000) pounds per year; and provided that the activity involves no potential emissions of any Class I substance or Class II substance as defined in Title 42 U.S.C. 7671; and further provided that the activity listed in § 20-256(c)(12) is not subject to an applicable requirement, as that term is defined in § 20-253. Potential emissions of any air pollutant that is both a criteria pollutant and a hazardous air pollutant shall be subject to the more stringent threshold of one thousand (1,000) pounds per year for the purposes of § 20-256(c)(12).

SECTION 96. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-256, is hereby amended so as to delete Section 20-256(c)(12)(ii) in its entirety and substitute in lieu thereof the following:

(ii) A single stack of an air contaminant source that emits no regulated gaseous pollutants or any pollutants defined at Section 20-253 "Regulated Air Pollutant" (5) of this ordinance and which does not have potential emissions, prior to being controlled, of more than 0.50 pound per hour of particulate matter, provided that the total of such emissions at an air contaminant source to which this insignificant activity designation is being applied amounts to less than 2.00 pounds per hour. For the purpose of this subparagraph, an air contaminant source includes all sources

located within a contiguous area and under common control. This insignificant activity designation does not apply to incinerators or sources emitting lead or lead compounds.

SECTION 97. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-256, is hereby amended so as to add the following Section 20-256(c)(12)(xxii):

(xxii) Surface coating operations using hand-held, non-refillable aerosol containers.

SECTION 98. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-258, is hereby amended so as to delete Section 20-258(h)(1) in its entirety and substitute in lieu thereof the following:

(1) Notice shall be given: by publication as an electronic notice (e-notice) on the Bureau website, along with a copy of the draft permit, for the duration of the public comment period; to persons on a mailing list developed by the Bureau, including those who request in writing to be on the list; and by other means designated by the Director, if necessary, to assure adequate notice to the affected public;

SECTION 99. That East Ridge Municipal Code, Title 20, Chapter 2, Section 20-268, is hereby amended so as to delete Section 20-268 in its entirety and substitute in lieu thereof the following:

BE IT FURTHER ORDAINED, that East Ridge Municipal Code, Title 20, Chapter 2, codifying ordinances as previously adopted be construed to be cumulative in effect, and it is here declared to be the legislative intent that compliance with any one or more provisions of that chapter shall not be construed as defense for non-compliance with any other applicable provisions of the Code or the Ordinance or rules or regulations thereof nor with any applicable provisions of that chapter.

SECTION 101. BE IT FURTHER ORDAINED, that if any section, part of a section, sentence, clause or phrase of this Ordinance is for any reason declared unconstitutional or otherwise invalid by any court of competent jurisdiction, such decision shall not affect the validity of any other portion of this Ordinance, and only such invalid portion shall be elided from this Ordinance.

BE IT FURTHER ORDAINED	, that this ordinance shall take effect immediately after
its passage, the public welfare of the City	requiring it.
