March 2026 Economic & Community Development Monthly Report

MONTHLY OVERVIEW:

Economic & Community Development continued advancement of a multi-year funding and capital project portfolio supporting infrastructure improvements, public safety initiatives, parks and recreation investments, and community development programs.

Throughout March, the department provided centralized coordination of grant compliance, financial reconciliation, reimbursement administration, and audit-sensitive documentation across 20+ active funding programs.

In addition to funding oversight, the department led and supported a range of active capital and development projects, including Venue 1921 completion activities, Community Center renovations, Camp Jordan improvements, roadway resurfacing coordination, and Springvale Park development.

The department also expanded efforts in digital services, public communications, and website development, while strengthening intergovernmental partnerships with Hamilton County, state agencies, utilities, and private sector stakeholders.

Strategic focus remains on ensuring compliance, improving internal processes, enhancing public-facing services, and positioning the City for long-term economic growth and investment.

- Coordinated and supported Venue 1921 final walk, punch list development, and operational readiness efforts
- Advanced citywide roadway resurfacing program through coordination with engineers, contractors, and utility providers
- Led development and implementation of new City website and digital contact systems
- Completed FY26 Q3 SRO Grant reporting, reconciliation, and compliance review
- Supported coordination of Camp Jordan capital planning efforts and FY27 Community Project Funding application with Hamilton County Government
- Initiated Springvale Park design phase under Hamilton County Government Community Grant
- Collaborated on NEPA environmental review efforts for Camp Jordan CDBG-funded project
- Conducted regional benchmarking and implementation planning efforts for HubSpot CRM system
- Advanced economic development pipeline projects including Scooter's Coffee, Ace Hardware expansion, and redevelopment of former Popeyes site
- Oversaw public communications strategy, including press releases, infrastructure updates, and community engagement efforts

- Continued oversight of Community Center Renovation (LPRF) and coordination of project progression
- Ongoing administration of Scruggs Road & Mack Smith Road Reconstruction (TIP funding)

- Managed cross-departmental coordination supporting infrastructure, parks, and facility-related capital projects
- Provided direct coordination with utility providers (Tennessee American Water, WWTa, and EPB) to align infrastructure work with roadway resurfacing operations
- Oversaw grant compliance documentation, reimbursement tracking, and audit-sensitive financial reporting across various funding sources
- Facilitated vendor coordination, engineering communication, and regulatory compliance efforts across active projects and city-wide initiatives
- Led internal process improvement efforts related to grant coding, documentation tracking, and financial reporting workflows
- Coordinated website development efforts, including ADA compliance requirements and content integration strategy
- Supported public facility use coordination, including community events hosted at City Hall

INFRASTRUCTURE & CAPITAL PROJECT COORDINATION:

- Coordinated implementation of 2026 Citywide Roadway Resurfacing Program, including phased milling and paving operations
- Facilitated coordination between contractors, engineering teams, and utility providers to prevent conflicts and minimize roadway rework
- Worked with Public Safety to evaluate roadway improvements, including safety enhancements such as rumble strip considerations
- Coordinated with Tennessee American Water and WWTa to align infrastructure improvements and avoid cutting newly paved roadways
- Supported ongoing capital planning and external funding coordination efforts
- Advanced Spring Creek Road median beautification and gateway enhancement project

City of East Ridge Police Chief's Monthly Report

The City of East Ridge Police Department responded to a total of 1,779 calls for service during March 2026.

The department filled a total of 51 open records requests from citizens and the District Attorney's Office.

A total of 604 citations were issued from 689 traffic stops.

The East Ridge Police Department made a total of 58 physical arrests that included 102 misdemeanor charges and 53 felony charges.

The East Ridge Police Department answered 2 calls within the City of Ridgeside and conducted daily self-initiated activities (directed patrols, park and walks, etc.).

Currently, three officers are in the Field Training Program and one officer is in the basic police academy.
