## TRACY COX



Tracy Cox was the first female attorney to be appointed as judge for Signal Mountain, TN. She also served as special judge in Rhea County. She began her career as a prosecutor for five years in Asheville, NC. She was a domestic violence attorney for Legal Aid and an assistant public defender in Maryville, TN.

Born and raised in Chattanooga, Tracy Cox received her Juris Doctorate from the University of Tennessee College of Law.

She has represented incarcerated juveniles as a John L. Attorney and spent five years representing victims of domestic violence as a VAWA attorney. She is regularly appointed as Guardian Ad Litem Attorney in conservatorship cases.

She has served on the Board of Directors for Children's Advocacy Centers in both Tennessee and North Carolina, a Child Fatality Review Team in North Carolina, the Chattanooga Family Justice Alliance Courts Task Force, and the Board of Governors for the Chattanooga Bar Association. She served on the Voices Committee for the Women's Fund of Greater Chattanooga. In 2013 she received from Mayor Coppinger and Judge Christie Sell a Certificate of Appreciation for her tireless efforts to promote domestic violence awareness throughout the City of Chattanooga.

Her practice covers divorce and family law, as well as conservatorship law.
